SUBJECT: FISCAL YEAR (FY) 2021-2022 CAPITAL IMPROVEMENT PROGRAM FILING OF

CONFORMANCE WITH THE GENERAL PLAN

#### **BACKGROUND:**

The Capital Improvement Program (CIP) identifies the proposed major projects or purchases over FY 2021-2022. Typically, the CIP is considered with the budget every year. Capital improvements are those individual construction projects and purchase of land, equipment, and contract services that need to be addressed in the new fiscal year or future years.

Pursuant to California Government Code Section 65401, the CIP "shall be submitted to the county or city planning agency for review.... as to conformity with the adopted general plan..." The Planning Commission fulfills the role of "planning agency" for this purpose. Once the Planning Commission finds the CIP consistent with the General Plan, the proposed CIP will be presented to the City Council for adoption and appropriate funding for the ensuing year CIP projects and five-year funding schedule.

### **DISCUSSION:**

Overall, the proposed projects included in the CIP are consistent with the intent of the existing General Plan of supporting growth and development, providing municipal services and improving/maintaining infrastructure and quality of life and safety. The CIP fulfills the following goals of the General Plan:

### **Our Prosperous Community:**

Action  $2.\overline{3}a$  - Invest in infrastructure and improve the public realm.

Policy 2.4 - Build on and grow West Covina's regional appeal.

### **Our Accessible Community:**

**Action 4.2b** - Review capital improvement projects to ensure that needs of non-motorized travelers are considered in planning, programming, design, reconstruction, retrofit, maintenance, construction, operations, and project development.

### **Our Resilient Community:**

**Action 5.8b** - Preserve the longevity and sound condition through evaluation and maintenance of the sewer infrastructure.

**Action 5.8.c** - Pursue construction of new or replacement sewer lines consistent with the City's Sewer System Management Plan.

**Policy 5.9** - Provide adequate facilities and services for the collection, transfer, recycling, and disposal of refuse.

### **Our Active Community:**

Policy 8.8 - Increase safety in public parks.

**Action 8.8a** - Provide adequate lighting; maintaining landscaping to maximize visibility; remove graffiti as soon as possible; remove trash, debris, weeds, etc. from public areas with ongoing maintenance of those public areas; and conduct regular police patrols and provide public safety information.

**Action 8.8b** - Continue to use the Capital Improvements Program to plan for the identification of available resources for park facility repair, upgrades, and replacements through the budget process.

### **ENVIRONMENTAL ANALYSIS:**

The California Environmental Quality Act (CEQA, Section 21000, et seq. of the California Public Resources Code), requires that the potential impacts of projects that will have a physical impact on the environment be analyzed prior to their construction. State CEQA Guidelines Sections 15061(b)(3) and 15378 exempts projects that have no potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. The Planning Commission's action involves determining the consistency of the FY 2021-2022 Capital Improvement Program with the City's General Plan. It does not directly authorize the construction of the individual projects enumerated in the listing. Therefore, the determination of consistency will not have a direct effect on the environment. As such, the potential action qualifies for this exemption and no further environmental review is required.

### **CONCLUSION:**

Environmental documentation for projects will be prepared or initiated prior to start of construction. The

resolution attachment lists all the projects in the CIP for the next year and a summary of the status of their environmental clearance.

### **RECOMMENDATION:**

Staff recommends that the Planning Commission adopt Resolution No. 21-6083, determining that the FY 2021-2022 budget of the draft CIP, as outlined, is in conformance with the General Plan.

SUBJECT: A RESOLUTION ADOPTING DESIGN GUIDELINES FOR SMALL WIRELESS

FACILITIES IN THE PUBLIC RIGHT-OF-WAY

#### **BACKGROUND:**

On September 27, 2018, the Federal Communications Commission (FCC) released a Declaratory Ruling and Third Report and Order (FCC Order) significantly limiting local management of Small Wireless Facilities (SWF). In summary, the FCC Order does the following:

- Defines SWFs as facilities (a) mounted on structures 50 feet or less in height (including antennas); or (b) mounted on structures no more than 10% taller than other adjacent structures; or (c) do not extend existing structures on which they are located to a height of more than 50 feet or by more than 10%, whichever is greater; AND each antenna is no more than 3 cubic feet in volume, and the total associated wireless equipment on one structure is no more than 28 cubic feet in volume.
- Limit fees local governments can charge to the actual and reasonable cost of providing service.
- Enacts shot clocks of 60 days for SWFs added to existing structures (regardless of whether the structure already supports a wireless service) and 90 days for SWFs proposing a new structure.
- Exempts from federal preemption aesthetic requirements for SWFs in the PROW unless they are (1) reasonable; (2) no more burdensome than those applied to other types of infrastructure deployments; (3) objective; and (4) published in advance.

On April 4, 2019, the California Supreme Court decided T-Mobile West, LLC vs. City and County of San Francisco, validating that municipalities can regulate the aesthetics of wireless facilities in the right of way.

On April 23, 2019, the Planning Commission adopted design guidelines for small wireless facilities located in the public right-of-way (Attachment No. 2) to address the FCC Order pertaining to aesthetic requirements being reasonable, not burdensome, and published in advance.

At its May 14, 2019 and July 23, 2019 meetings, the Planning Commission held study sessions on wireless facilities in the public right-of-way. During the July 23, 2019 study session, the Planning Commission voted to direct staff to draft an ordinance that:

- References Design Guidelines in order to allow flexibility for modifications that may be needed in the future:
- Allows administrative review by staff for all wireless facilities in compliance with Design Guidelines and Planning Commission review if not in compliance with Design Guidelines;
- Identifies a review threshold that requires wireless telecommunication facilities to be at least 250 feet from another wireless telecommunication in order to qualify for administrative review by staff;
- Requires wireless telecommunication facilities to be set back 15 to 30 feet from residential structures (depending on zoning designation).

Subsequent to that discussion, Administrative Use Permit (AUP) applications were submitted for 5 small wireless facilities in the public right-of-way proposed on top of replacement street light poles in the Woodside Village area. These facilities were located off of Amar Road, east of Azusa Avenue. The Planning Commission approved the AUP applications on July 23, 2019 and an appeal was filed on August 5, 2019. On October 1,

2019 the City Council voted 3-2 to overturn the Planning Commission's decision to approve the 5 small wireless facilities and denied the AUP applications. The City Council felt that the proposed small wireless facilities were not sufficiently concealed.

On November 26, 2019 and January 28, 2020, the Planning Commission held public hearings to review Code Amendment No. 16-03 and adopted Resolution No. 20-6018 recommending that the City Council approve the presented Ordinance No. 2470.

At its May 5, 2020 meeting, the City Council reviewed Code Amendment No. 16-03 and adopted Ordinance No. 2470 (Attachment No. 3).

At its July 28, 2020 and August 25, 2020 meeting, the Planning Commission held study sessions to update the Design Guidelines for Small Wireless Facilities in the public right-of-way in order to make it consistent with the recently updated West Covina Municipal Code (WCMC). During the study sessions staff presented the Planning Commission examples of Design Guidelines from other cities. The Planning Commission expressed the need for a simple document that is easy to understand and straight forward. In addition, the Planning Commission agreed on including hierarchy of design and location preferences in the City's Design Guidelines. The Planning Commission directed staff to note that facilities with above ground equipment will automatically require a discretionary application review process and to require a tapered design if the antenna/equipment shroud is slightly larger in diameter than the pole that it is on. Minutes to the Planning Commission Study Sessions are included as Attachment No. 4.

### **DISCUSSION:**

The proposed Design Guidelines identifies the City's design preference and provides acceptable design standards for ministerial review if the SWF's design complies with the following:

- Equipment to be placed on existing poles designed to match its color and texture. Replacement and/or new poles should be aggregate/marbilite to match color and shape of existing poles in the vicinity.
- Antennas and RRUs are required to be placed above the light pole and shrouded.
- Shrouds should be the same diameter as the pole. A tapered design should be utilized if the pole is slightly larger than the shroud.
- Wires and cables should be contained within the shroud and run inside the pole, or in conduits that are subdued and matches the adjacent surface.
- Wireless and/or underground metering is required

Placement within the hierarchy of design and location preference does not indicate or guarantee that the review process for the proposed wireless facility will be ministerial.

If adopted, staff will provide the City Council a copy of the adopted SWF Design Guidelines and make the Guidelines available at the Planning counter, Engineering counter, and the City's website.

The SWF Design Guidelines may be amended as necessary (i.e. per the request of City Council, Planning Commission, or to make consistent with new State and/or Federal mandates/laws).

### **ENVIRONMENTAL DETERMINATION:**

The proposal is not subject to the California Environmental Quality Act (CEQA) per Section 15061(b)(3) of the CEQA Guidelines, which provides that CEQA only applies to activity that results in direct or reasonably foreseeable indirect physical change in the environment and for activity considered to be a project, respectively. The revision to the Small Wireless Facility Design Guidelines would not result in a physical change in the environment because it would clarify design standards and submittal requirements.

### **RECOMMENDATION:**

Staff is recommending the Planning Commission adopt Resolution No. 21-6082, approving Design Guidelines for Small Wireless Facilities in the Public Right of Way.
